ROAD TRAFFIC ACTS

DURHAM COUNTY COUNCIL

The County Council of Durham (The Mount, Eighton Banks) (Prohibition of Through Traffic) Order, 1959

The Durham County Council have applied to the Minister of Transport and Civil Aviation for confirmation of an Order made by them under the Road Traffic Act, 1930, as amended, the effect of which will be to prohibit, with certain exceptions, any person from driving or causing or permitting to be driven any vehicle other than a handcart, perambulator, invalid carriage or pedal cycle on that length of unclassified road in the Chester-le-Street Rural District which extends from its junction near the Bowes Railway Level Crossing with the Wrekenton—Black Fell Class III Road in a south-easterly direction for a distance of 170 yards.
