(b) Notices under the Companies Acts in the standard form prescribed for London Gazette notices by The Companies (Winding-up) Rules, 1949, and The Companies (Forms) Order, 1949, Statutory Instruments Nos. 330 and 382 of 1949; 7. 6d. Other Companies Winding-Up Notices at the rates given under (f). (c) Notices under the County Courts Act, 1934, when received from the Registrar of County Court

Judgments: 15s.

(d) Friendly Societies Notices: 7s. 6d.

(e) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: 15s. Other Notices under the Act at rates given under (f).

(f) All other Notices or Advertisements, including Applications to Parliament and Scotch Sequestrations, will be charged by the number of lines appearing as plain matter in the type of the Gazette:

Table or tabular matter will be charged at the rate of £1 10s. per quarter page or part thereof.
