SURREY COUNTY COUNCIL

Town and Country Planning General Development Order, 1950

Notice is hereby given that the County Council of the Administrative County of Surrey in exercise of the powers conferred upon them by the Town and Country Planning Act, 1947 and Article 4 of the Town and Country Planning General Development Order, 1950, have made a Direction that the permission granted by Article 3 of the said Order shall not apply to the Development described in the first schedule hereto (being Development comprised within Class VI of the first schedule to the said Order) upon the land forming parts or portions of the Rural District of Dorking and Horley described in the second schedule hereto and shown hatched black on drawing No. CP/59/669 which Direction was approved by the Minister of Housing and Local Government on the 11th August 1959.

A certified copy of the Direction and of the plan referred to therein has been deposited at the County Records Office, County Hall, Kingston-upon-Thames, at the office of the Clerk of the Dorking and Horley Rural District Council, Chalkpit Lane, Dorking, and at the office of the Engineer and Surveyor of the Dorking and Horley Rural District Council, Massetts Road, Horley, and may be seen there at all reasonable office hours.

FIRST SCHEDULE

Any development of the kinds specified in paragraph 1 of Class VI of the first schedule to the said Order, being the erection of any structure used for the purposes of poultry production, including the breeding hatching sexing rearing killing plucking or dressing of poultry, or the keeping of poultry for the production of eggs, where such structure—

- (i) alone or together with any structure, any part of which is within a distance of 100 feet therefrom exceeds 7,500 cubic feet (as ascertained by external measurement), or
- (ii) exceeds 500 square feet in aggregate floor space (as ascertained by external measurement), and in the case of a building with a ridged roof, exceeds 7 feet in height at the ridge or 5 feet at the eaves, and in any other case exceeds 5 feet 6 inches in height.

SECOND SCHEDULE

All those pieces or parcels of land known as The Birches, Weare Street, Ockley, in the Rural District of Dorking and Horley in the County of Surrey comprising approximately 82 acres as shown hatched black on Drawing No. CP. 59/669.

NEW TOWNS ACT, 1946

HEMEL HEMPSTEAD DEVELOPMENT CORPORATION

Hemel Hempstead Development Corporation (No. 22) Central Area Compulsory Purchase Order, 1959

Notice is hereby given that the Hemel Hempstead Development Corporation in pursuance of their powers under section 4 of the New Towns Act, 1946, on the 18th day of August 1959, made an Order which has been submitted for confirmation by the Minister of Housing and Local Government authorising them to purchase compulsorily for the purposes of the New Town of Hemel Hempstead the lands described in the Schedule hereto.

A copy of the Order, and of the map referred to therein, have been deposited at the Town Hall, Hemel Hempstead, and will be open for inspection without payment of fee between the hours of 10 a.m. and 4 p.m. on Mondays to Fridays.

Any objection to the Order must be made in writing, stating the grounds of the objection and addressed to the Minister of Housing and Local Government, Whitehall, London S.W.1, before the 28th day of September 1959.

The Minister is not, in all cases, required to arrange for objections to be heard by a person appointed by him for that purpose. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made as the objector may have no further opportunity to make such a statement.

Any owner or occupier of any land to which the Order relates may send to the Hemel Hempstead Development Corporation at the address below, a request in writing to serve him with a notice that the Order has been confirmed and naming a place where a copy of the Order and of the map and of any descriptive matter annexed thereto, may be seen. Such request should contain a statement of the name, postal address and the interest in the land of the owner or occupier, and particulars sufficient to enable the extent and boundaries of the land to be identified.
