The City of Liverpool (Central Area) (No Waiting) Order, 1959

The City Council of Liverpool proposes to make an Order under the Road Traffic Act, 1930, as amended, the effect of which will be, viz:

1. To revoke the City Council of Liverpool (Traffic Regulation) Order, 1945 (which relates to the prohibi-tion of waiting on the west side of Exchange Street East).

2. To prohibit waiting:

(a) in any of the roads and lengths of road set out below at all times: Camden Street (East side).

Leigh Street.

Leigh Street. London Road (Northerly carriageway) between its junction with the easterly side of Norton Street and its junction with Craven Street. London Road (Southerly carriageway) between its junction with the easterly side of Seymour Street and its junction with Greek Street. Lord Nelson Street (Lime Street to Pudsey Street)

Street). Ormond Street (Old Hall Street to Bixteth Street).

Williamson Square (East side of easterly carriageway) (Houghton Street to Upper Dawson Street).

(b) in any of the roads specified in the first column below within 120 feet of their junction with the roads specified in the second column:

Christian Street (Hunter Street to Islington). Church Street (Waterloo Place to Whitechapel). Clayton Square (main carriageway). Concert Street (Wood Street to Seel Street).

Crosshall Street (south west side) (Whitechapel to Victoria Street). Elliot Street.

Lime Street (Ranelagh Street to Gloucester Street).

London Road (Lime Street to Norton Street). Lord Street.

Mount Pleasant (Benson Street to Ranelagh Place).

Newington (south east side) (Cropper Street to Bold Street). Norton Street.

Parker Street.

(d) between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays and between the hours of 8 a.m. and 1 p.m. on Saturdays except on Christmas Day, Good Friday or Bank Holiday in the following roads or lengths of road, viz: Bixteth Street (Edmund Street to St. Paul's Source) Square).

Canning Place (south side of southerly carriage-way) (Park Lane to Frederick Street). Cheapside (south west side) (Dale Street to a point 30 yards from its junction with Dale Street).

Cheapside (north east side). Cumberland Street. Derby Square (Fenwick Street to Castle Street and James Street to South Castle Street). Eberle Street.

Edmund Street (north west side) (Earle Street to

These restrictions are subject to exceptions covering persons boarding or alighting from vehicles, the loading and unloading of vehicles and the use of vehicles in connection with funerals, building opera-tions, demolitions, the removal of traffic obstructions and the maintenance of the roads or the services therein.

Nothing in the Order shall apply to any hackney carriage waiting upon any duly authorised cab rank. Objections to the proposal must be sent in writing

to the undersigned by the 30th October 1959.
