

*Waiting Restrictions**Metropolitan Borough of Wandsworth*

The Minister of Transport and Civil Aviation in accordance with the London Traffic Act, 1924, section 10, as amended, proposes to refer to the London and Home Counties Traffic Advisory Committee for their advice and report a modified proposal that he should make Regulations to restrict waiting by vehicles between the hours of 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in Ramsden Road, Balham, from a point forty-five feet north of its junction with Balham High Road to a point opposite the southern boundary of the Baptist Church.

(Exceptions would be provided in the Regulations to permit vehicles to wait—to pick up and set down passengers, to load and unload goods, to carry out essential services, or while in use by local authorities in an emergency.)

Objections to the making of such Regulations may be sent to the Secretary, Ministry of Transport and Civil Aviation, 21-37 Hereford Road, London W.2, not later than 30th October 1959, quoting RTC 17/242/03.

*Supplies and Services (Defence Purposes) Act, 1951**Highways at Greenham Common, Berks*

*The Boroughs of Gillingham and Chatham**(Traffic Regulation) (Revocation) Order, 1959.*

On 30th September 1959, the Minister of Transport and Civil Aviation made the above-mentioned Order under the Road Traffic Act, 1930, as amended, which will come into operation on 21st October 1959.

The effect of the Order is to revoke "The Boroughs of Gillingham and Chatham (Traffic Regulation) Order, 1950" (which imposed unilateral waiting restrictions between 8 a.m. and 8 p.m. in that length of the London—Canterbury—Dover Trunk Road, known as Watling Street (A.2), in the said Boroughs, between its junction with Cleave Road and a point 344 yards east thereof.)
