say: "We, the Church Commissioners, acting in pursu-ance of the Pastoral Reorganisation Measure, 1949, 1952 and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Honourable and Most the consent of the Right Honourable and Most Reverend Geoffrey, Archbishop of Canterbury, act-ing as Guardian of the Spiritualities of the See of Norwich (in witness whereof he has signed this Scheme) for effecting (1) the union of the benefice of Letheringsett with Bayfield and part of the benefice of Wiveton with Glandford, and (2) the union of the benefice of Cley next the Sea and the remaining part of the benefice of Wiveton with Gland-ford, all of which benefices are situate in the diocese of Norwich. of Norwich.

## " SCHEME

"1. Union of the benefice of Letheringsett with Bayfield and part of the benefice of Wiveton with Glandford

"(1) The part of the benefice of Wiveton with Glandford which coincides with the area of the chapelry of Glandford shall be severed from the said benefice and the part so severed and the benefice of Letheringsett with Bayfield shall be permanently united tearther to form one benefice with cure of united together to form one benefice with cure of souls under the style of 'The United Benefice of Letheringsett with Bayfield with Glandford' but the parish of Letheringsett with Bayfield shall continue in all respects distinct and the area of the chapelry of Glandford shall become and be a separate and distinct parish for ecclesiastical purposes under the style of 'The Parish of Glandford' and the church of Saint Martin shall be the parish church thereof.

"(2) Upon the union taking effect the Reverend Charles Lawrence Scruton Linnell, if he is then incumbent of the benefice of Letheringsett with Bayfield, shall, with his consent (which has been given to us in writing) be the first incumbent of the united benefice united benefice.

"(3) Parsonage House. Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Letheringsett with Bayfield shall, if at that date it so belongs to the said benefice, be the house of residence of the incumbent of the united the house of residence of the incumbent of the united benefice.

"2. Union of the benefice of Cley next the Sea and the remaining part of the benefice of Wiveton with Glandford

"(1) That part of the benefice of Wiveton with "(1) That part of the benefice of Wivefon Will Glandford which remains after the severance referred to in clause 1 of this Scheme and the benefice of Cley next the Sea shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Cley with Wiveton' but the remaining part of the parish
