The QUEEN has been graciously pleased to approve the award of the George Medal, in recognition of gallant conduct in Germany to:

Major Peter BLUNT, M.B.E. (335303), Royal Army Service Corps.

On the 10th May 1959, a ten ton vehicle, carrying a full load of petrol, driven by Driver JOHNSTON with Driver PIENAROSA as passenger, crashed into a tree. The front of the vehicle was crushed, and the two men were trapped in the cab. The load shifted forward, some of the cans burst and petrol flowed over the vehicle. The batteries were shorting and rubber covered cables were smouldering. There was every likelihood of the whole vehicle bursting into flames.

Major BLUNT arrived on the scene, called for the Fire Brigade and recovery vehicles, and managed to extricate JOHNSTON by cutting away part of the engine cowling. He could not free PIENAROSA, who was badly hurt but he climbed in and applied a tourniquet to his leg to stop the bleeding.

No morphine was available until a doctor appeared on the scene. Major BLUNT borrowed his syringe and again climbed into the cab. Here he gave PIENAROSA an injection and sat with him to calm him until the recovery vehicles arrived and the man was freed. Major BLUNT was inside the wreckage, with his clothes soaked in petrol, for over an hour, with no chance of escape had fire broken out, as appeared to be inevitable. He showed complete disregard for his own safety in conditions of great danger.
