The QUEEN has been graciously pleased to approve the award of the British Empire Medal for Gallantry (Military Division) to the under-mentioned:

3516276 Acting Sergeant Michael CHILDS, Royal Air Force.

On 29th May 1959, Sergeant Childs, who is 23 years of age and has been flying for only one year, was the Air Quartermaster in a Hastings aircraft which crashed and caught fire shortly after take-off from Khartoum. Following the failure of one engine a violent juddering affected the aircraft and some of the passengers became agitated. Sergeant Childs, although badly shaken himself, restored confidence amongst his passengers and prepared them for a crash landing, moving about the aircraft until the last moment before impact, ensuring that all safety belts were fastened. Immediately the aircraft crashed it caught fire, but his quick action in opening the emergency exit, together with the example he set by the matter of fact way in which he marshalled his passengers, was an inspiration to them and prevented any further difficulty. Although considerably shaken by the crash Sergeant Childs stayed inside the burning aircraft until each of his 25 passengers was safe, having, with total disregard for his own safety, gone right into the blazing remains of the aircraft fuselage to bring out an N.C.O. who had been dazed by a falling stretcher post. He was the last to leave the burning aircraft. Through his calm efficiency he maintained order in very difficult circumstances and thus ensured the safety and well being of those in his charge. His courage and devotion to duty were of the highest order and his unconcern for his personal safety was instrumental in averting what could so easily have been a major disaster.
