Order, 1960

(Made 20th January 1960)

This Order, which comes into force on the 1st March 1960, requires that imported Irish once-tested cattle must be isolated from cattle on neighbouring farms. Previously, such cattle had only to be isolated from other cattle on the premises to which they had been sent. A further requirement of the Order makes it necessary to obtain a licence before any Irish cattle are taken on to farms which are subject to movement restrictions imposed to control the spread of bovine tuberculosis.
