

And whereas in the year One thousand nine hundred and thirty the Governing Body acquired by purchase the freehold messuages lands and hereditaments delineated on the said plan and therein coloured burnt sienna for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the Twenty first day of December One thousand nine hundred and twenty nine, which Scheme was duly approved and sanctioned by an Order of His late Majesty King George V in Council dated the Twenty eighth day of March One thousand nine hundred and thirty

And whereas in the year One thousand nine hundred and thirty seven the Governing Body acquired by purchase the freehold messuage and premises delineated on the said plan and therein coloured yellow hatched green for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the First day of May One thousand nine hundred and thirty seven, which Scheme was duly approved and sanctioned by an Order of His late Majesty King George VI in Council dated the Twenty ninth day of July One thousand nine hundred and thirty seven

And whereas in the year One thousand nine hundred and forty five the Governing Body acquired by purchase the freehold piece or parcel of land delineated on the said plan and therein coloured red hatched red for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the Third day of April One thousand nine hundred and forty five which Scheme was duly approved and sanctioned by an Order of His late Majesty King George VI in Council dated the Third day of August One thousand nine hundred and forty five

And whereas in the year One thousand nine hundred and forty eight the Governing Body acquired by purchase the freehold messuage or dwellinghouse cottage and land delineated on the said plan and therein coloured brown hatched brown for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the Twenty eighth day of June One thousand nine hundred and forty eight which Scheme was duly approved and sanctioned by an Order of His late Majesty King George VI in Council dated the Twenty sixth day of November One thousand nine hundred and forty eight

And whereas in the year One thousand nine hundred and fifty three the Governing Body acquired the freehold land delineated on the said plan and thereon coloured dark blue for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the Twelfth day of March One thousand nine hundred and fifty three which Scheme was duly approved and sanctioned by an Order of Her Majesty Queen Elizabeth II on the Nineteenth day of June One thousand nine hundred and fifty three

And whereas in the year One thousand nine hundred and fifty six the Governing Body acquired by purchase the freehold dwellinghouse drawn on the said plan and thereon coloured orange hatched black for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the Thirteenth day of January One thousand nine hundred and fifty six which Scheme was duly approved and sanctioned by an Order of Her Majesty Queen Elizabeth II in Council dated the Twenty fourth day of April One thousand nine hundred and fifty six.

And whereas all the said purchases were greatly to the benefit of the School and were rendered necessary chiefly by the increase in the number of boys attending the School

And whereas further accommodation is required for masters and other purposes at the School and the Governing Body have sought to acquire a dwellinghouse near to the School which would be suitable for such purposes

And whereas the Governing Body in furtherance of such intention did on the Twenty seventh day of October One thousand nine hundred and fifty nine enter into an agreement with Dorothy Annie Dyas Cecil Hough Dyas John Reginald Dyas and Alan John Shay to purchase for the sum of Six thousand nine hundred pounds a freehold dwellinghouse land and premises known as Tudor House being the dwellinghouse more particularly described in the

schedule to these presents and coloured blue hatched black on the plan hereto annexed

And whereas the purchase of the said premises is very desirable in the interests of the School not only for the reasons hereinbefore appearing but also because they immediately adjoin other property of the School

And whereas it is apprehended that the Governing Body have not power under the original Scheme or the said Amending Schemes to acquire the said premises

THE GOVERNING BODY DO HEREBY PROPOSE BY VIRTUE OF AND IN PURSUANCE OF THE POWERS HEREBEFORE MENTIONED TO ALTER THE ORIGINAL SCHEME AS FOLLOWS THAT IS TO SAY:

That the Original Scheme shall throughout be read and construed as though the land and property described in the schedule hereto and delineated on the plan annexed hereto and thereon coloured blue hatched black had been described in the Schedule to the Original Scheme and delineated on the plan thereto annexed and thereon coloured as last aforesaid and that the said Agreement of the Twenty seventh day of October One thousand nine hundred and fifty nine and the carrying into effect thereof may be deemed to have been authorised by the Original Scheme

The SCHEDULE hereinbefore referred to

All those pieces or parcels of land with the buildings erected thereon or on some part thereof known as Tudor House Kingsland Shrewsbury in the County of Salop containing in the whole One acre and twenty perches or thereabouts and comprising enclosures numbered 866 and 867 on the Ordnance Survey Map which said property is for the purpose of reference and illustration only and not of warranty delineated and coloured blue hatched black on the plan annexed hereto
