The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under section 2 (7) of the Currency and Bank Notes Act, 1954, entitled The Fiduciary Note Issue (Extension of Period) Order, 1960.

This Order extends for a further two years the period during which the Fiduciary Issue may stand at amounts continuously exceeding £1,575 million.

The Order comes into operation on 14th March 1960 and has been published as Statutory Instruments 1960, No. 327.

The Import Duties (Process) (No. 1) Order, 1960.

This Order revokes the Import Duties (Process) (No. 1) Order revokes the import Duties (ricess) (No. 1) Order, levokes the import Duties Act, section (5) of section eight of the Import Duties Act, 1958, to apply the provisions of that section to certain plastic sheeting sent abroad for lamination, so that on its return it would be chargeable with customs duty in respect of the value of the lamina-tion process only. The present Tariff classifica-tion of this sheeting is such that section eight now applies to it by virtue of subsections (1) to (4) and the Order is therefore no longer necessary.

The Order comes into operation on 5th March 1960, and has been published as Statutory Instruments 1960, No. 334.
