#### RURAL DISTRICT COUNCIL OF MALDON

*Maldon Rural District Council (North Fambridge No. 1) Extinguishment Order, 1959*

Notice is hereby given that on the 27th day of April 1960, the Minister of Housing and Local Government confirmed with modifications the above Order.

The effect of the Order is to extinguish in the parish of North Fambridge

- (a) the public right of way commencing at its junction with Rectory Road approximately 700 feet north of Grooms Farm and proceeding in a southerly direction for a distance of approximately 560 feet through O.S. field No. 40 over the chaseway to Grooms Farm, passing over the railway track, through O.S. field No. 38 and then proceeding through O.S. fields Nos. 42, 48, 72, 73, 77, 113a, 113, 116b, 116 and 122, for a distance of approximately 5,450 feet to its junction with the highway leading to the River Crouch at a point approximately 300 feet south west of the "Ferry Boat Inn";
- (b) the public right of way commencing on the western boundary of field No. 113a at its junction with the footpath described in (a) above and proceeding in an easterly direction across the said field for a distance of approximately 650 feet and terminating on the western boundary of the Churchyard approximately 40 feet west of Holy Trinity Church.

The rights of way will be extinguished on the 26th May 1960.

The Order becomes operative as from the 12th day of May 1960, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

*Further modifications of the Draft Map and Statement*

Notice is hereby given that the Warwickshire County Council in exercise of the powers conferred on them by sub-section 3 of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the draft rights of way map and statement, prepared under section 27 of the above-mentioned Act, in relation to rights of way in the Rugby Rural District, by altering to "bridleway" the description of the ways, described as "road used as a public path", referred to in the First Schedule hereto by the numbers allotted to them respectively in the said draft rights of way map and statement, and by altering to "footpath" the description of the ways, described as "road used as a public path", referred to in the Second Schedule hereto by the said numbers.
