CITY OF BIRMINGHAM

The City of Birmingham Smoke Control (No. 4) Order, 1960

1. Notice is hereby given that the Lord Mayor, Aldermen and Citizens of the City of Birmingham, acting by the Council in exercise of the powers conferred on them by section II of the Clean Air Act, 1956, on the 5th day of April 1960, made an Order entitled The City of Birmingham Smoke Control (No. 4) Order, 1960, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

2. Subject to the exemptions provided by the Order and by virtue of section II (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels, include anthracite, coke and other carbonised fuels, gas and electricity.

3. If confirmed the Order will not come into operation before the 3rd day of April 1961, or before a later date determined by the Minister of Housing and Local Government.

4. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Department in the Council House at all reasonable times during the period of six weeks from the 30th day of May 1960.

5. Within the said period any person who will be affected by the Order may, by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

ROAD TRAFFIC ACTS

DEVON COUNTY COUNCIL

The County of Devon (Riverside Road, Lynmouth)
(Prohibition and Restriction of Waiting) Order, 1959

On 19th May 1960, the Devon County Council made an Order under the Road Traffic Act, 1930, as amended the effect of which is (i) to restrict waiting by vehicles to thirty minutes in any hour on the north-east side of Riverside Road, Lynmouth, from a point 59 yards north-west of its junction with the Lynton-Countisbury Road (A.39) north-westwards for a distance of 210 yards, (ii) to prohibit waiting (with certain exceptions) over the remainder of the road. These restrictions will apply between the hours of 10 a.m. and 6 p.m. daily during the period from 1st May to 30th September (both dates inclusive) in every year.
