(b) Notices under the Companies Acts in the standard form prescribed for London Gazette notices by The Companies (Winding-up) Rules, 1949, and The Companies (Forms) Order, 1949, Statutory Instruments Nos. 330 and 382 of 1949; 7s. 6d. Other Companies Winding-Up Notices at the rates given under (f).

(c) Notices under the County Courts Act, 1934, when received from the Registrar of County Court Judgments: 15s.

(d) Friendly Societies Notices: 7s. 6d.

(e) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: 15. Other Notices under the Act at rates given under (f).
