#### RATES OF INTEREST ON LOCAL LOANS

The Lords Commissioners of Her Majesty's Treasury hereby give notice that in pursuance of the powers conferred on them by the Public Works Loans Act, 1897 (60 and 61 Vict. c. 51), the Public Works Loans Act, 1935 (26 Geo. 5 & 1 Edw. 8 c. 5) and the Local Authorities Loans Act, 1945 (8 & 9 Geo. 6 c. 18), they have directed by their Minute of 14th July 1960, that on loans advanced to local authorities from the Local Loans Fund, on and after 16th July 1960, there shall be chargeable in lieu of the rates fixed by the Treasury Minute of 28th January 1960, the following rates of interest:

Loans for not more than five years ...	6½
Loans for more than five years but not more than fifteen years ...	6½
Loans for more than fifteen years but not more than thirty years ...	6½
Loans for more than thirty years ...	6
