(b) the Grant of Probate or Letters of Administration relating to the estate to which the advertisement refers is produced by the executor or administrator for inspection at the time the advertisement is submitted.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.

- (b) Notices under the Companies Acts in the standard form prescribed for London Gazette notices by The Companies (Winding-up) Rules, 1949, and The Companies (Forms) Order, 1949, Statutory Instruments Nos. 330 and 382 of 1949: 7s. 6d. Other Companies Winding-Up Notices at the rates given under (f).
- (c) Notices under the County Courts Act, 1934, when received from the Registrar of County Court Judgments: 15s.
 - (d) Friendly Societies Notices: 7s. 6d.
