*The Borough of Chatham (Hills Terrace)
(Prohibition of Waiting) Order, 1960*

The Chatham Borough Council propose to make an Order under the Road Traffic Act, 1930, as amended, the effect of which will be to prohibit vehicles from waiting in Hills Terrace, Chatham, between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays inclusive. It is intended to exempt from this Order any vehicle waiting only for so long as may be necessary (a) to enable a person or persons to board or alight from the vehicle; (b) for goods to be loaded on to or unloaded from the vehicle, and (c) for the vehicle to be used in connection with any building operations or demolition, the removal of any obstruction to traffic, or the maintenance of the road or the equipment therein.

**TOWN AND COUNTRY PLANNING
ACT, 1947**

MIDDLESEX COUNTY COUNCIL

County of Middlesex Development Plan

Notice is hereby given that proposals for alterations or additions to the above Development Plan were on the 15th August 1960 submitted to the Minister of Housing and Local Government.

The proposals relate to (a) land on the east side of Lyon Road, bounded on the north-east by St. John's Road and on the south-east by the rear boundaries of the residential properties on the north side of Gayton Road and having an area of approximately 2.60 acres; (b) land on the west side of Lyon Road at the rear of commercial properties on the east side of Station Road and having an area of 2.25 acres all situate within the Borough of Harrow.

Certified copies of the proposals as submitted have been deposited for public inspection at the Borough Engineer and Surveyor's Department, "Cottesmore", Uxbridge Road, Stanmore, Middlesex, and also in the County Planning Department, 10 Great George Street, Westminster, London S.W.1.

The copies of the proposals so deposited together with copies of the relevant extracts of the Development Plan are available for inspection free of charge by all persons interested at the places mentioned above between the hours of 9 a.m. and 5.15 p.m. on Mondays to Fridays and 9 a.m. and 12 noon on Saturdays (except in the case of the copy in the County Planning Department which will not be available for inspection on Saturdays).

Any objection or representation with reference to the proposals may be sent in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, before the 1st day of November 1960 and any such objection or representation should state the grounds on which it is made.

Persons making an objection may register their names and addresses with the Clerk of the Middlesex County Council, Guildhall, Westminster, London S.W.1, and will then be entitled to receive notice of any amendment of the Development Plan made as a result of the proposals.
