"Gratuities for officers not granted permanent commissions

- "7. Officers transferred to the Emergency List on completing a full engagement of 5 or 10 years, as the case may be, to be eligible for gratuity at such rates as may from time to time be laid down by Order in Council.
- "8. Officers invalided on account of disability not due to causes within their own control to be eligible for gratuity at the full rates payable in accordance with above, proportionate to their length of service.
- "9. Officers released from the Active List at any other time, for reasons other than invaliding as provided in Clause 8, at Admiralty discretion, to be allowed such gratuity as may be determined in accordance with the general conditions laid down from time to time, by Order in Council, for awards in such circumstances."

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Com-missioners of the Admirality are to give the necessary directions herein accordingly.
