- (c) radio communications and maintenance during communication flights ;
- (d) flight testing of radio equipment when aircrew are not available;
 - (e) aerial photography;

(f) medical attendance in the Naval Air Ambulance service or employed on search and rescue work.

"Extra Pay for Casual Duty in Submarines

The rates at which the allowance is paid are to be brought into line with those of 'Special Service Pay' to personnel in category (C).

"Exercises in Submarine Escape

Payment will be at the rate of 'Special Service Pay' appropriate to free divers (4s. 0d. a day) for each day on which practical escape drill is carried out.

"Master-at-Arms Allowance

The rate of this allowance will be increased to 2s. 0d. a day.

"Instructional Allowance

The rate of this allowance will be increased to 1s. 0d. a day.
