The QUBEN has been graciously pleased, on the advice of Her Majesty's Australian Ministers, to approve the award of the George Medal to the undermentioned:

Flight Lieutenant Robert Fran (039336), Royal Australian Air Force. Francis WYATT

(039336), Royal Australian Air Force. Flight Lieutenant Wyatt was authorised to fly on a routine training exercise in the navigator's seat of a Canberra aircraft on 8th (March 1960. During the take-off run a loss of engine power occurred and the aircraft subsequently ran off the end of the strip and crashed in a very battered state with its wheels up, fuel lines fractured, with both engines running and a fire developing under each of the main planes. After freeing himself from his entangled position, Flight Lieutenant Wyatt moved forward to assist the pilot whose right foot had become jammed in the cockpit. Regardless of the immediate danger to his own life from fire or explosions, the possibility of which must have been uppermost in his mind because of their frequency after aircraft crashes, Flight of their frequency after aircraft crashes, Flight Lieutenant Wyatt remained in the cabin of the aircraft calmly working until he had successfully freed the pilot's foot. Only when the pilot's safe escape was assured did Flight Lieutenant Wyatt leave the aircraft, approximately five minutes after it came to rest. Throughout the emergency Flight Lieutenant Wyatt showed a complete disregard for his own safety. His coolness, self discipline and courage in the face of great danger were in keeping with the highest tradi-tions of the Service. By his act of valour and gallant behaviour he had set a magnificent example to others.

The QUEEN has been graciously pleased, on the advice of Her Majesty's Australian Ministers, to approve the award of the British Empire Medal for Gallantry (Military Division) to the undermentioned:

A.294 Sergeant Victor ANDERSON, Australian Air Force. Roval

On 8th March 1960, Sergeant Anderson was N.C.O. in charge of First Line Servicing No. 2 (B) Squadron when he witnessed a flying accident to Canberra A.34-239. Sergeant Anderson immediately assumed control of the rescue operations. On arrival at the aircraft approximately four minutes after the crash and just prior to the escape of the crew, he saw that fires had developed under both engines and along the starboard side of the fuselage. Furthermore, the port engine was idling, and the starboard engine was running at approximately two-thirds throttle. Un-deterred by the danger of fire and the risk of fuel explosions, he successfully blocked off the intake to the port engine with vegetation, thus stopping the engine. Sergeant Anderson then endeavoured un-successfully to obtain water from the fire hose to stop the starboard engine by feeding water into No. 2 tank. He then obtained an axe and personally cut through the engine access panel and levered the high pressure cock "off." Meanwhile, the port engine had caught fire internally. Sergeant Anderson then cut the port fuel line with 'an axe, thereby stopping the fuel flow to the engine and preventing possible explosion. These tasks he completed before foam was available in approximately six minutes from his time of arrival. During this emergency. Sorgeant Anderson his time of arrival. in approximately six minutes from his time of arrival. buring this emergency, Sorgeant Anderson displayed leadership, initiative, and skill of a very high order. His prompt and efficient action considerably reduced the extent of the fire and the risk of explosion. This contributed materially to the safe rescue of the crew and the later salvage of the aircraft. His total dis-regard for his own personal safety was an inspiration to all.
