HONOURS AND AWARDS

CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD

St. James's Palace, London S.W.1. 25th October (1960.

The QUEEN has been graciously pleased, on the advice of Her Majesty's Canadian Ministers, to approve the undermentioned award of the British Empire Medal.

Awarded the British Empire Medal for Gallantry (Civil Division):

Brian Pickup, Constable, Windsor Police Department, Windsor, Ontario.

Two armed, masked robbers entered a bank in Windsor, Ontario, forced the staff, including the Manager, to one corner of the building, and removed the cash from the three tellers' cages. One of the bandits then herded the staff into the vault of the bandis then herded the start into the valit but two of the bank employees managed to set off the alarm as they walked by. Constable Pickup, on motor-cycle duty heard that the alarm had sounded at the bank and immediately went there. sounded at the bank and immediately went there. As he arrived, he saw a man running from the front door of the bank. The Constable jumped off his motor-cycle, raced towards the man and tackled him as he came near, throwing him to the pavement, and holding him fast. As Pickup held the first robber, the second robber ran from the bank and shot the Constable. Two workmen ran to his assistance and helped to hold the robber until other Police Constables arrived. The second bandit surrendered after an exchange of gun fire. Constable Pickup tackled an armed robber with no thought to his own safety.
