The QUEEN has been graciously pleased to approve the award of the British Empire Medal (Military Division) for Gallantry to the undermentioned:

23626459 Gunner Colin TURNER, 33 Parachute Light Regiment, Royal Regiment of Artillery.

On the 7th May 1960, Gunner TURNER was near the railway line above Government Road, Aldershot. A boy suddenly rushed screaming from the direction of the track, drawing his attention to a small girl between the rails.

He immediately ran to the track to find the child trapped between the running rail and the electric conductor rail, with her dress burning and her arm and leg in contact with the live rail. A train was approaching at the time. TURNER immediately wrenched the small girl free and threw her to a companion, jumping off the track himself as the train passed by.

Knowing the risks involved in detaching the girl from the live electric rail and in doing so when a train was approaching, Gunner TURNER displayed a gallant disregard for his own safety. His brave action saved the child's life.
