A PROCLAMATION

FOR APPOINTING TUESDAY, DECEMBER 27TH, 1960, A BANK HOLIDAY AND A PUBLIC HOLIDAY IN ENGLAND AND WALES AND IN NORTHERN IRELAND.

ELIZABETH R.

Whereas We consider it desirable that Tuesday, the twenty-seventh day of December one thousand nine hundred and sixty, should be observed as a holiday in England and Wales and in Northern Ireland:

We do hereby appoint the said twenty-seventh day of December to be observed as a Public Holiday in England and Wales and in Northern Ireland and by this Our Royal Proclamation command the said day to be so observed and all Our loving subjects to order themselves accordingly:

And We do further hereby, by and with the advice of Our Privy Council, in exercise of the powers conferred by the Bank Holidays Act, 1871, and the Customs and Excise Act, 1952, appoint the said twenty-seventh day of December to be observed in England and Wales and in Northern Ireland as a Bank Holiday, and as a holiday in the customs and excise, under and in accordance with the said Acts.

Given at Our Court at Buckingham Palace this twenty-sixth day of October, in the year of our Lord one thousand nine hundred and sixty, and in the Ninth year of Our Reign.

A PROCLAMATION

CALLING IN ALL FARTHING

ELIZABETH R.

Whereas under section eleven of the Coinage Act, 1870, We have power, with the advice of Our Privy Council, by Proclamation to call in coins of any date or denomination, or any coins before the date in the Proclamation mentioned:

And Whereas it now appears to Us desirable to call in all farthings:

We, therefore, with the advice of Our Privy Council and in pursuance of section eleven of the Coinage Act, 1870, do hereby call in by the thirty-first day of December One thousand nine hundred and sixty all farthings coined before that date and direct that after such thirty-first day of December One thousand nine hundred and sixty, such coins shall not be current or legal tender within Our

United Kingdom of Great Britain and Northern Ireland.

Given at Our Court at Buckingham Palace this twenty-sixth day of October, in the year of our Lord One thousand nine hundred and sixty, and in the Ninth year of Our Reign.
