Whereas a Representation duly made to Her Majesty in Council by the Minister of Housing and Local Government that, for the protection of the Public Health, burials should be discontinued as hereinafter directed in the churchyard of St. Faith, Havant, in the Urban District of Havant and Waterloo in the County of Hampshire, has, in pursuance of an Order in Council made the 7th day of June 1960, and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section one of the Burial Act, 1853, and of all other powers Her enabling, is pleased by and with the advice of Her Privy Council to order, and it is hereby ordered, as follows:

1. Burials shall be discontinued forthwith and entirely in the churchyard of St. Faith, Havant, in the said Urban District.

2. This Order may be cited as the Burial Grounds (Havant and Waterloo) Order, 1960.

Whereas a Representation duly made to Her Majesty in Council by the Minister of Housing and Local Government that, for the protection of the Public Health, burials should be discontinued as hereinafter directed in the St. Mary's Cemetery, Osney, Oxford, has, in pursuance of an Order in Council made the 23rd day of June 1960, and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section one of the Burial Act, 1853 (16 & 17 Vict. c. 134), and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. Burials shall be discontinued forthwith and entirely in the St. Mary's Cemetery, Osney, Oxford, Provided that—

(a) In any vault or walled grave now existing in the said Cemetery, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stone-work or brickwork properly cemented.

(b) In any earthen grave now existing in the said Cemetery, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject

to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds (St. Mary's Cemetery, Osney, Oxford) Order, 1960.
