

*Highways Act, 1959*

The Minister of Transport hereby gives notice that he has made a Scheme under section 11 of the above Act, the effect of which is:

(a) to authorise the Minister to provide a special road:

(i) from a point on the London—Bristol Trunk Road (West Cromwell Road Extension) at Chiswick in the County of Middlesex in a general westerly direction over and following the route of the said trunk road (The Great West Road) on viaduct to Boston Manor Road; thence in a north-westerly direction to Osterley Park and then in a general westerly direction to join the route of the proposed North of Harmondsworth—Langley Special Road; and

(ii) from a point on the route of the special road described in paragraph (i) above approximately 515 yards east of the point where it crosses Sipson Road in a southerly direction for a distance of approximately 1,600 yards,

for the exclusive use of traffic of Classes I and II which are set out in the Fourth Schedule to the Act:

(b) to authorise the Minister to construct as part of the special road a bridge carrying it over the navigable waters of the Grand Union Canal; and

(c) to provide that the special road in so far as it is to be provided by new construction will become a trunk road on the date of coming into operation of the Scheme.

Any person aggrieved by the Scheme and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of that Act, or of any regulations made thereunder, has not been complied with in relation to the Scheme, may, within six weeks of 4th November 1960, apply to the High

Court for the suspension or quashing of the Scheme or of any provision contained therein.

*Highways Act, 1959*

*The Winchester—Preston Trunk Road and the North of Dunston—Stafford Trunk Road (North of Dunston Diversion) Order, 1960.*

The Minister of Transport hereby gives notice that he has made an Order under section 7 of the above Act, the effect of which is to authorise the Minister to provide—

(a) that the two roads which he proposes to construct near Dunston in the County of Stafford shall become trunk roads on the date when the Order comes into operation and

(b) that the two lengths of the Winchester—Preston Trunk Road and the North of Dunston—Stafford Trunk Road to be superseded shall cease to be trunk roads on 1st April next after the date on which notice is given by the Minister to the Stafford County Council (who will become the highway authority responsible for those lengths) that the new road is opened for through traffic.
