Road Traffic Act, 1960

Road Traffic and Roads Improvement Act, 1960

Notice is hereby given that the Minister of Transport has made "The Parking Places (Woolwich) (No. 1) Order, 1961" (S.I. 1961 No. 157), which designates parking places on certain highways in the Metropolitan Borough of Woolwich at which charges may be made by the Council of that Borough for the vehicles authorised by the Order to be left in those parking places.
