The Hydrocarbon Oil Duties (Drawback) (No. 1) Order, 1961.

This Order increases from 1.6 gallons per cwt. to 1.9 gallons per cwt. the rate used for determining the quantity of hydrocarbon oil in respect of which drawback is allowed on the export of certain solid of new drawbacks of customs or excise duty paid in respect of hydrocarbon oil used in the manufac-ture of solid neoprene synthetic rubber, neoprene latex and certain lubricating oil viscosity modifiers.
