The existing public right of way commencing at a point marked A immediately adjacent to the south-western corner of Perretts Copse Ordnance Parcel No. 66a (Ordnance Survey Sheet Sussex (West) XXXVI/16 (Revision of 1937)) proceeding in a south-western and southerly direction for approximately 260 feet (passing immediately in front of the dwellinghouse known as Perretts) and thence east and south into a sunken lane to the point marked B is to be extinguished at the expiration of twenty-eight days from the date of the confirmation of the Order.

The Order becomes operative as from the 12th day of May 1961, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.
