## TAVISTOCK URBAN DISTRICT COUNCIL

The Tavistock (Street Parking Places) Order 1961
The Urban District Council of Tavistock propose to make an Order under section 81 of the Road Traffic Act, 1960, and sub-section (2) of section 11 of the Road Traffic and Roads Improvement Act, 1960, the effect of which will be:

1. To allow unrestricted parking for all classes of vehicles between the hours of 8 a.m. and midnight throughout the year on the following lengths of road, EXCEPT that during the period commencing 1st June and ending 30th September in each year parking on these roads will be restricted to a period of forty-five minutes between the hours of $10 \mathrm{a} . \mathrm{m}$. and $4 \mathrm{p} . \mathrm{m}$. on week days only:

Plymouth Road. On the northern side of the roadway extending from the boundary between Nos. 1 and 2 Bedford Place to a point 5 yards from the junction with Russell Street.
Russell Street. On both sides of the roadway (excluding the entrances to Garden Lane) from a point 23 yards from the junction with West Street to a point 18 yards from the junction with Plymouth Road on the western side, and 5 yards from the junction with Plymouth Road on the eastern side.
West Street. On both sides of the roadway (excluding the entrance to Rocky Hill) from the western boundary of No. 25 West Street to the electricity standard immediately beyond West Street Avenue -a distance of 67 yards.
Market Road. On the southern side of the roadway from a point 15 yards from the junction with Abbey Bridge to the western boundary of the slaughterhouse offices (except for the two portions reserved for the use of the Ambulance and Fire Brigade).
2. To allow restricted parking for all classes of vehicles for a period of forty-five minutes between the hours of 10 a.m. and $4 \mathrm{p} . \mathrm{m}$. on week days only, on the following lengths of road during the period commencing 1st June and ending 30th September in each vear:

Dolvin Road. On the southern side of the roadway extending from the western boundary of the Burial Ground to the western boundary of No. 4 Dolvin Road.
Elbow Lare. On the eastern side of the roadway from a point 5 yards from the junction with Duke Street to the southern side of the vehicular entrance to the rear of The Congregational Church.
West Street. On both sides of the roadway (excluding the entrances to King Street and Market Street) from the eastern boundary of No. 1 West Street to the western boundary of No. 5 West Street.
Duke Street. On both sides of the roadway (excluding the entrances to Pepper Street and Elbow Lane) on the northern side from a point 5 yards from the junction with Drake Road to the western boundary of the White Hart Hotel, on the southern side from a point 5 yards from the junction with Bedford Square to the western boundary of No. 49 Brook Street.
Drake Road. On the western side of the roadway only (excluding the junction with Pym Street) from a point 5 yards from the junction with Bedford Square to the southern boundary of the railway viaduct.
Bedford Square. For coaches only, on the eastern side from a point 5 yards from the junction with Duke Street to a point 5 yards from the vehicular entrance to the Pannier Market.
3. To allow restricted parking for all classes of vehicles for a period of thirty minutes between the hours of $10 \mathrm{a} . \mathrm{m}$. and 4 p.m. on week days only, on the following lengths of road during the period commencing 1st June and ending 30th September in each year:
North Street. On the eastern side of the roadway only from a point 5 yards from the junction with West Street to a point 5 yards from the junction with Pym Street.
King Street. On the western side of the roadway only from the northern boundary of No. 2 King Street to the northern boundary of No. 6 King Street.

## The Royal County of Berkshire

(Station Road, Croft Road and St. Georges Road, Wallingford) (No Waiting) Order, 1961
On the 31st May 1961, the Berkshire County Council marde an Order under the Road Traffic Act, 1960, the effect of which is to prevent any person from causing or permitting a vehicle to wait between the hours of $8 \mathrm{a} . \mathrm{m}$. and $6.30 \mathrm{p} . \mathrm{m}$. on Mondays to Saturdays inclusive on the following lengths of road:
(a) Station Road (A.4130) from its junction with Croft Road to a point level with the eastern boundary of No. 15 Station Road.
(b) Croft Road from its junction with Station Road (A.4130) in a southerly direction for a distance of 70 yards.
(c) St. George's Road from its junction with Station Road (A. 4100 ) in a northerly direction for a distance of 15 yards.
Exceptions are included in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any funeral, building operation or demolitition the removal of any obstruction to traffic, the main'tenance of the road or the services therein.
The Order is operative from Monday, 5th June 19611.
