### MONMOUTHSHIRE COUNTY COUNCIL (Cemetery Road, Chepstow) (Weight Restriction) Order, 1960

On the 23rd May 1961, the Minister of Transport confirmed the above-named Order made by the Mon-mouthshire County Council under the Road Traffic Act, 1960, the effect of which is:

- 1. Save as provided in Article 2 hereof, no person shall drive or cause or permit to be driven any vehicle the weight of which, whether laden or unladen, exceeds 3 tons on the length of road specified in the Schedule hereto.
- 2. Nothing in Article 1 hereof, shall prevent the driving upon the length of road referred to in that Article of any vehicle which is being used:
  - (a) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road;
  - (b) for the purposes of agriculture in connection with land adjacent to that length of road or for the conveyance or haulage of timber felled upon that land :
  - (c) in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act, 1878.

# MONMOUTHSHIRE COUNTY COUNCIL
