

FLINTSHIRE COUNTY COUNCIL

*The County of Flint (Footpaths at Ffrwd, Llanfynydd)
Public Path Extinguishment Order, 1961*

The above Order made on the 20th day of June 1961 is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to extinguish the public rights of way running from:

- (a) the Red Lion Inn, Ffrwd to a point 154 yards west thereof;
- (b) a point 264 yards east of Cae Clogwyn, Ffrwd for a distance of 130 yards south of that point; and
- (c) from Mount Pleasant Farm, Ffrwd to a point 260 yards east thereof.

CHARD RURAL DISTRICT COUNCIL

*Chard Rural District Council (Forton 5/5A) Public
Path Extinguishment Order, 1961*

On the 14th day of June 1961, the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to extinguish as from the 28th day of June 1961, the public right of way running from a point at or near to the Southwestern corner of O.S. field Number 770 to a point (approximately a distance of 840 feet in a Northeasterly direction) at the North-east corner of O.S. field Number 764 giving access onto the classified road B.3162 leading from Forton to Chard.
