Exceptions are made in the Order to allow the conveyance of persons and goods to and from premises in or adjacent to Friary Avenue and to enable vehicles to be used in connection with agriculture, building operations, public works and military training operaoperations, public works and military training operations.

The County of Essex (Various Streets, Walton-on-the-Naze) (Prohibition of Waiting) Order, 1961

New Pier Street-from its junction with The Parade westwards to its junction with Crescent Road.

The Parade (sometimes in part known as Marine Parade)—from a point 40 yards east of its junction with Church Road to its junction with Prince's Esplanade.

Newgate Street-from its junction with The Parade north-westwards to its junction with Station Street.

Old Pier Street—from its junction with The Parade to a point 15 yards north-west thereof.

Suffolk Street—from its junction with The Parade

Suffolk Street—from its junction with The Parade to a point 20 yards west thereof.

Saville Street—from its junction with The Parade to a point 15 yards north-west thereof.

High Street—from its junction with Prince's Esplanade to a point 20 yards south-west thereof.

Prince's Esplanade—from its junction with High Street to a point 65 yards north-east thereof.

Kino Road—(a) from its junction with High Street and Prince's Esplanade north-westwards on the south-west side of the island site for a distance

south-west side of the island site for a distance of 56 yards; and (b) from the latter-mentioned point south-eastwards on the north-east side of the said island site for a distance of 37 yards to the junction with Prince's Esplanade.

Exceptions are contained in the Order authorising a vehicle to wait for a person to board or alight, or for goods to be loaded or unloaded, or in connection with building operations or the repair and main-tenance of the road or of the various services therein.
