

NORFOLK COUNTY COUNCIL

Downham Rural District

Notice is given that application will be made by the Norfolk County Council to the Justices of the Peace sitting at the Court Hall, Downham Market, at 10.30 a.m. on Thursday, 3rd August 1961, for an Order under section 108 of the Highways Act, 1959, authorising the stopping up for the purposes of all traffic of six lengths of the highway known as the Stoke Ferry-Tottenham Road (A.134) in the Parish of Stradsett over a distance of approximately $\frac{1}{2}$ mile which are unnecessary following the realignment of that highway northward from its junction with the Downham Market-Swaffham Road (A.1122).

The lengths of highway to be closed are shown coloured blue on the plan deposited at County Offices, Thorpe Road, Norwich, and at the offices of the Downham Rural District Council, 21 London Road, Downham Market, where it is open for public inspection free of charge during normal office hours.

Any person using the highway or any person aggrieved by the making of the said Order has a right to be heard before the Justices.

Maldon Rural District Council (Bohuns Hall, Tollesbury) (No. 4) Public Path Extinguishment Order, 1961.

The above Order made on the 21st day of June 1961, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to extinguish the public right of way running from its junction with and on the eastern side of Prentice Hall Lane immediately opposite Prentice Hall Farm House and proceeding in a northerly direction for a distance of approximately 1,235 feet through field Nod. 294 on the Ordnance Survey Map (1922 Edition) for the parish of Tollesbury and thence in a northerly direction through the said O.S. field Nod. 294 for a distance of approximately 140 feet and terminating at its junction with West Street at a point approximately 800 feet east of the junction of Prentice Hall Lane with West Street.

Maldon Rural District Council (Bohuns Hall, Tollesbury) (No. 5) Public Path Diversion Order, 1961

The above Order made on the 21st day of June 1961, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to divert the public right of way running from the south-eastern corner of field No. 296 on the Ordnance Survey Map (1922 Edition) at a point approximately 1,020 feet east of Prentice Hall Farm House and at its junction with a path or track leading from Prentice Hall Lane and proceeding in a north-easterly direction for a distance of approximately 1,130 feet through O.S. field Nod. 296 and O.S. field Nod. 300 terminating on the eastern side of O.S. field Nod. 300 where it joins the public footpath to Elysian Gardens, to a line commencing in the south-eastern corner of the said O.S. field No. 296 and proceeding in an easterly direction

for a distance of approximately 35 feet to the boundary of O.S. field No. 352 and thence along the northern boundary of the said field Nod. 352 for a distance of approximately 900 feet and thence in a northerly direction along the eastern boundary of O.S. field No. 300 for a distance of approximately 660 feet terminating at a point where it joins the footpath leading to Elysian Gardens, Tollesbury.

CIRENCESTER RURAL DISTRICT COUNCIL

Cirencester Rural District Council (Parish of Ampney St. Peter) Public Path Diversion Order, 1961

On the 21st day of June 1961, the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to divert the public right of way at Charlham House Farmhouse, Ampney St. Peter as follows:

The public footpath from a point near Charlham House Farmhouse in the Parish of Ampney St. Peter in the north-east corner of field No. 129 on O.S. Sheet Glos. L11/13 1921 Edition and running in an easterly direction some 130 feet to a point adjoining the Ampney St. Peter road—to be diverted so as to commence at the same point near Charlham House Farmhouse and thence in an easterly direction for a distance of approximately 130 feet to a point adjoining the road to Ampney St. Peter some 30 feet further south in field No. 129 on O.S. Sheet Glos. L11/13 1921 Edition. The old footpath will be closed with effect from the 19th July 1961.

A copy of the confirmed Order and the map contained in it has been deposited at the offices of the Cirencester Rural District Council, 5 Dyer Street, Cirencester and may be inspected free of charge between the hours of 9 a.m. and 1 p.m. and 2 p.m. and 5.15 p.m. each weekday except Saturdays and between the hours of 9 a.m. and 12.30 p.m. on Saturdays.

The Order becomes operative as from the 30th day of June 1961, but if any person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein on the grounds that it is not within the powers of the Highways Act,
