The QUEEN has been graciously pleased, on the advice of Her Majesty's New Zealand Ministers, to approve the award of the British Empire Medal for Gallantry (Military Division) to the undermentioned:

No. 797578 Private Brian James STUART, The New Zealand Regiment

On the 10th December 1960, Private Stuart, with other members of his platoon, was rafting down the Sungee Sara in Perak. The river was heavily swollen by recent rains. The raft hit a log and capsized throwing its crew into the river. One soldier was carried into the fast mid-stream current. Although a strong swimmer, he was swept towards dangerous rapids.

In spite of being tired after five hours of strenuous In spite of being tired after five hours of stremuous rafting Private Stuart at once swam to the rescue. The water was fast and turbulent with jagged rocks above and below the surface. Despite severe buffeting Stuart persisted until he could no longer see the drowning man and was himself on the point of being swept into the rapids. He struggled to the bank totally exhausted. In his determined attempt to save the life of a comrade he displayed courage of the highest order.
