#### *Imports of Handles for Umbrellas, Sunshades and Walking Sticks*

In accordance with the provisions of sub-section 4 of section 2 of the Merchandise Marks Act, 1926, the Board of Trade announce that in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin at the time of importation, sale and exposure for sale in the United Kingdom, they have made a reference to the Standing Committee (General Merchandise) appointed by the Board of Trade under the Act in respect of the following goods:

Handles and parts incorporating handles (including blanks identifiable as unfinished handles) and knobs for umbrellas, sunshades and walking sticks.
