TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 8th December 1961, at 11 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £30,000,000 for Bills due 63 days after date and to the amount of £230,000,000 for Bills due 91 days after date.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 11th December 1961, to Saturday, the 16th December 1961, inclusive.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different currencies and for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

Upon the Petition of the above-named A. V. Cotty & Co. Limited and of Albert Vivian Cotty and Eva Doris Cotty respectively members of the said Company on the 26th October 1961 preferred unto this Court

And upon hearing Counsel for the Petitioners and for the Registrar of Companies (the Respondent)

And upon reading the said Petition the Affidavit of Eva Doris Cotty and the Affidavit of Albert Merry both filed the 2nd November 1961 and the Exhibits in the said Affidavits respectively referred to

And there being no opposition on behalf of Her Majesty to the relief sought by the said Petition as appeared from the said Affidavit of Albert Merry and the Exhibit thereto
