

PORT TALBOT BOROUGH COUNCIL

Borough of Port Talbot (Margam Terrace) (One Way) Orders, Nos. 1, 2, 3, 4, 5, 6, 7 and 8, 1962.

The Port Talbot Borough Council propose to make Orders under Sections 26 and 27 of the Road Traffic Act, 1960 the effect of which will be that no person shall drive or cause or permit any vehicle to be driven on any of the lengths of road specified in the first column of the Schedule to this notice otherwise than in the direction specified opposite to that length in the second column of the said Schedule.

The Council of the Borough of Port Talbot (Central Infants School) (Prohibition of Waiting) Order, 1961

On the 29th November 1961, the Port Talbot Borough Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is to prohibit vehicles to wait between the hours of 8 a.m. and 6 p.m. on Monday to Friday of each week, on the north side of the road fronting the Central Infants School, Port Talbot from its junction with Broad Street for a distance of 100 feet in a north westerly direction.

The County Council of Lancashire (Newtown Street, Shaw) (Prohibition of Waiting) Order, 1961

On the 21st December 1961, the Lancashire County Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is to prohibit with certain exceptions the waiting of vehicles on both sides of the whole length of Newtown Street, Shaw, in the Urban District of Crompton.

The Order will come into operation on Monday, the 8th January 1962.

BERKSHIRE COUNTY COUNCIL

The Royal County of Berkshire (Restricted Roads) (No. 1) Order, 1961

On the 1st August 1961, the Minister of Transport confirmed the above-named Order made by the Berkshire County Council under Sections 20 and 21 of the Road Traffic Act, 1960, the effect of which is to derestrict the length of roads described in the First Schedule and restrict the length of roads described in the Second Schedule.

FIRST SCHEDULE

<i>Name or Description of Road</i>	<i>Section of Road to be derestricted</i>
(a) Bracknell-Windsor Road (A. 332)	(a) A length of 750 yards at Bracknell from a point 200 yards north of High Street to the junction of Bay Road.
(b) Downshire Way, Bracknell	(b) The length of road which extends from a point 66 yards west of the centre of Bagshot Road (A. 322) roundabout in a north-westerly direction for a distance of 1,000 yards.

SECOND SCHEDULE

(1) Binfield Road (B. 3018) Bracknell	(1) That length which extends from a point 100 yards north-west of its junction with Stoney Road to a point 35 yards south-east of its junction with Jocks Lane a distance of approximately 314 yards.
(2) Crowthorne Road (A. 3095) Bracknell	(2) That length which extends from a point 23 yards south-west of its junction with Downshire Way in a general south-westerly direction for a distance of 266 yards.
(3) Park Road (B. 3022) Bracknell	(3) That length which extends from its junction with Holly Spring Lane in a south-westerly direction for a distance of 713 yards.
