- (a) they are signed or attested by a Solicitor of the Supreme Court, or
 (b) the Practipe relating to the advertisement is produced for inspection at the time the advertisement
- (c) a duplicate Practipe relating to the advertisement is produced for inspection at the time the advertisement is submitted, or
 (c) a duplicate Practipe relating to the advertisement is produced for retention by the London Gazette Office.

(d) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: 15s. Other Notices under the Act at rates given under (f).

 (c) Deputy Lieutenants Commissions: 10s. for each Commission.
 (f) All other Notices or Advertisements, including Applications to Parliament and Scotch Sequestrations, will be charged by the number of lines appearing as plain matter in the type of the Gazette:
