DURHAM COUNTY WATER BOARD

Barnard Castle Rural District Council

Notice is hereby given that the Durham County Water Board (hereinafter referred to as "the Board") and the Barnard Castle Rural District Council (hereinafter referred to as "the Council") are about to apply to the Minister of Housing and Local Government for an Order under section 9 (1) of the Water Act, 1945.

The counties and districts comprised wholly or partly in the area affected by the intended Order are the administrative counties of Durham and Northumberland, the city of Durham, the urban districts of Bishop Auckland, Blaydon, Brandon and Byshottles, Chester-le-Street, Consett, Crook and Willington, Hetton, Houghton-le-Spring, Shildon, Spennymoor, Stanley, Tow Law and Whickham and the rural districts of Barnard Castle, Chester-le-Street, Darlington, Durham, Easington, Hexham, Lanchester, Sedgfield, Stockton and Weardale.
