PETROLEUM (PRODUCTION) ACT, 1934

In pursuance of section 2 (3) of the Petroleum (Production) Act, 1934, the Minister of Power hereby gives notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, as amended, he has granted to Esso Petroleum Company Limited, 36 Queen Anne's Gate, Westminster, London S.W.1, four prospecting licences, details of which are given in the Schedule below. The boundaries are described from the 2½ in. Ordnance Survey Map.

Maps showing boundaries of the areas may be inspected on application to the Ministry of Power, Petroleum Division, Thames House South, Millbank, London S.W.1.

SCHEDULE

An Area of approximately 159 square miles in the Counties of Berks and Wilts

Northern Boundary

Commencing at Swindon, the boundary follows the A.345 eastwards to Little Moor, thence along the secondary road to Wanborough whence it proceeds in a south-easterly direction across Wanborough Plain to Baydon, Lambourn and Great Shefford.

Eastern Boundary

From Great Shefford the boundary follows the A.338 in a south-westerly direction to Hungerford.

Southern Boundary

From Hungerford the boundary follows the railway line westwards to the station at Woodborough

Western Boundary

From the station at Woodborough the boundary follows the road northwards through Alton Barnes, East Kennett, West Kennett, Winterbourne Monkton and along the A.361 to Swindon.

An Area of approximately 181 square miles in the Counties of Berks, Hampshire and Wilts

Northern Boundary

Commencing at the station at Woodborough, Wilts, the boundary follows the railway line eastwards to Hungerford.
