The QUEEN'S Most Excellent Majesty in Council

Whereas a Representation duly made to Her Majesty in Council by the Mänister of Housing and Local Government that, for the protection of the Public Health, burnals should be discontinued as herein-after directed in the Restormed Church Cemetery, in the Parish of Lostwithiel in the County of Corn wall, has, in pursuance of an Order in Council made the 21st day of December, 1961, and duly pub-lished, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section one of the Burial Act, 1853, 16 & 17 Vict. c. 134, and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. Burials shall be discontinued forthwith and en-tirely in the Restormel Ohurch Cemetery in the said Parish.

Randall, Mrs. Rosina Wenmouth, Mr. Richard Treleaven, Mrs. May Carne and Mrs. Emma Jones, subject in each case to the condition that no part of the coffin containing the body shall be at a part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
