Other Companies Winding-Up Notices at the rates given under (f). (c) Friendly Societies Notices: 7s. 6d. (d) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: 15s. Other Notices under the Act at rates given under (f). (e) Deputy Lieutenants Commissions: 10s. for each Commission. (f) All other Notices or Advertisements including Applications to Parliament and South Sacutations

f) All other Notices or Advertisements, including Applications to Parliament and Scotch Sequestrations, will be charged by the number of lines appearing as plain matter in the type of the Gazette:

If not exceeding 10 lines of printed matter: 15s.

For each additional 5 lines or under: 7s. 6d.
