The QUEEN has been graciously pleased to approve the award of the George Medal to the under-mentioned:

T/23834695 Driver (Acting Lance Corporal) James Crossland, Royal Army Service Corps.

On the 21st February, 1962, Lance Corporal Crossland was in charge of a 10 ton vehicle, being towed through the village of Ovenstaedt in Germany, which was in collision with a third large vehicle. All three vehicles were loaded with petrol in jerricans, some of which fell into the road and became ignited.

Crossland first ordered the driver of the towing vehicle to move the two vehicles forward away from the blaze and out of the village. He then ran to the assistance of the driver of the third vehicle who, after attempting to subdue the flames with an extinguisher, collapsed exhausted. The tyres, floor board and load of the vehicle were by now well alight and there was a blazing pool of petrol on the road.

(Realising that there might not be time to clear the people of the village from the vicinity and that loss of life and damage would result if the vehicle exploded where it stood Lance Corporal Crossland entered it and drove it half a mile to a place of safety. He did this in spite of the fact that the lorry was burning fiercely and the jerricans upon it were exploding with increasing frequency.

He gave no thought to his own safety and displayed a high degree of decision, gallantry and devotion to duty.
