Northern Boundary

Eastern Boundary

From Eynsham the boundary follows the A.4141 in a south-easterly direction to the junction with the A.420 at Botley, thence along the A.420 southwards through Besselsleigh to the A.338 and along the A.338 to the railway line at Wantage Road Station.

Southern Boundary

From Wantage Road Station the boundary follows the railway line westwards to the outskirts of Swindon where the A.361 crosses the railway at Stratton Green.

Western Boundary
