## CONFIRMATION OF PUBLIC PATH ORDER

*City of Sheffield (Manor Lodge) Public Path Diversion Order, 1962*

On the 21st day of June 1962, the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to divert the public right of way running from Manor Lane at a point marked "A" on the map opposite Manor Park Crescent and extending for a distance of 120 yards or thereabouts in a northerly direction to a point marked "B" on the map, to a line running along a new public footpath from Manor Lane at a point marked "C" on the map 14 yards or thereabouts west of No. 205 Manor Lane and extending for a distance of 67 yards or thereabouts in a northerly direction to a point marked "D" on the map, thence for a distance of 38 yards or thereabouts in a north-westerly direction to a point marked "E" on the map, thence for a distance of 23 yards or thereabouts in a westerly direction to a point marked "F" on the map, and thence for a distance of 30 yards or thereabouts in a north-westerly direction to the point marked "B" on the map 120 yards or thereabouts north of Manor Lane, the diversion to take effect as from the 13th July 1962.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected, free of charge, at the Town Clerk's Office, Town Hall, Sheffield 1, between 8.45 a.m. and 5.15 p.m. on Mondays to Fridays.

The Order becomes operative as from the 6th day of July 1962, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulations made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

*Notice of proposal to apply for an Order authorising the stopping up of a highway*

Notice is hereby given that the Council of the Borough of Chesterfield being the highway authority for the highway hereinafter mentioned intend to apply to the Magistrates' Court sitting at Chesterfield on the 13th day of August 1962 at the hour of 10 o'clock in the forenoon for an Order under section 108 of the Highways Act, 1959 authorising those parts of the highway known as Red Lane, Chesterfield, as are specified in the schedule hereto to be stopped up on the ground that they are unnecessary.
