Notice of Application for Emergency Order-West Okement River

Whereas in view of the continued drought a serious deficiency of supplies of water is threatened in those areas of the Board receiving supplies from the Prewley Waterworks.

And whereas pursuant to section 77 of the North Devon Water Board Act, 1945, the Board shall not abstract more than \$00,000 gallons of water per day from the West Okement River and in addition onequarter of the flow of that river in excess of 1,200,000 gallons per day, provided that at no time shall the flow thereof be reduced below 400,000 gallons per

Notice is therefore given that in order to maintain an adequate supply of water the Board have applied to the Minister of Housing and Local Government for an Order, pursuant to section 1 (b) of the Water Act, 1958, to enable them, for the period of the present emergency and in any case not exceeding four months, to abstract at the intake on the said West Okement River all water flowing in the said river in excess of 200,000 gallons per day provided that during the period of the said Order the Board shall augment the flow of the said river from the Me'don Lake at a point adjacent thereto by such quantity of water as is necessary to increase the flow immediately below the Vellake Gauge Weir to 400,000 gallons per day, the quantity of water to be pumped from the said take not to exceed 200,000 gallons per day.
