(b) extends until 31st July 1963, the operation of the drawback scheme for creped paper used in the manufacture of exported adhesive tape; and

(c) formally applies to Commonwealth goods the principle now applicable to goods of E.F.T.A. origin, in cases where their eligibility for drawback when exported without change of state depends on the rate of import duty paid, of determining their eligibility by reference to the full rate and not the preferential rate of import
