*Diversion of a portion of the highway known as
Trostra Lane, leading from Trostra to Sluvad at
Trostra in the County of Monmouth.*

Notice is hereby given that on Friday the 14th day of September 1962, application will be made to Her Majesty's Justices of the Peace for the County of Monmouth, assembled in Petty Sessions at Pontypool in the said County, at 10.30 o'clock in the forenoon, for an Order authorising the diversion for the purposes of all traffic of that portion of the highway known as Trostra Lane, at Trostra in the said County, from a point 80 yards North of the boundary separating the Pontypool Rural and Urban Districts at Trostra Lane aforesaid to a point 30 yards South thereof, a length of 110 yards.

Leeming Lane Recreation Ground (Footpath No.
17) Public Path Diversion Order, 1962.*

The above Order made on the 1st day of February 1962, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to divert the public footpath commencing at point A, the northern corner of the Recreation Ground known as the "Leeming Lane Recreation Ground", Ordnance Survey Plan No. SK 5463, 1957 Edition, and proceeding southeastwards to a point adjacent to the southern corner thereof. The length of the footpath is 210 yards. This diversion is made in order that such footpath shall follow a line commencing at the point A previously referred to and proceeding in an easterly direction to the eastern corner of the said Leeming Lane Recreation Ground. The length of the path is 143 yards.

*Tonbridge Rural District (Matfield) Public Path
Diversion Order, 1962*

The above Order was made on the 18th day of July 1962, and is due to be submitted to the Minister of Housing and Local Government for confirmation.

The effect of the Order will be to divert the public right of way of undefined width running from a point approximately 80 feet east of the main road B.2160 from Tunbridge Wells to Paddock Wood in a north-easterly direction for a distance of approximately 140 feet to a line running from the aforesaid point approximately 80 feet east of the main road B.2160 in a south-easterly direction for a distance of approximately 100 feet and thence in an easterly and northerly direction for a distance of approximately 120 feet to meet the existing right of way.
