ROAD TRAFFIC ACTS

STOURBRIDGE BOROUGH COUNCIL

The Borough of Stourbridge (Oldswinford) (Traffic Regulation) Order, 1962

Notice is hereby given that on the 28th August 1962, the Stourbridge Borough Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the Order coming into effect on the 1st November 1962. The effect of the Order is (a) to revoke the Borough of Stourbridge (Oldswinford) (Traffic Regulation) Order, 1957; (b) to prohibit vehicles to wait between the hours of 8 a.m. and 8 p.m. in any of the following lengths of road: of the following lengths of road:

(1) Hagley Road to the west side between a point 88 and 1/3rd yards south of its junction with Heath Lane and a point 41 and 2/3rds yards north of that junction.

(4) Heath Lane between its junction with Hagley Road and a point 67 yards west of that junction.

The Order contains exemptions enabling persons to board or alight from vehicles; enabling goods to be loaded on to or unloaded from a vehicle; enabling vehicles to be used in connection with building operations or works in connection with sewers, mains, pipes nons or works in connection with sewers, mains, pipes or telegraph lines; enabling vehicles to take in petrol, oil, water or air from any garage in any of the roads. The Order also exempts vehicles owned by a funeral director or owner of funeral vehicles when in use as part of a funeral cortège or otherwise in connection with a funeral with a funeral.
