On the southern side of New Road from the junc-tion with Palmerston Road for a distance of 160 feet eastwards.

On the western side of East Park Terrace from the junction with New Road for a distance north-wards of 150 feet. On the eastern side of East Park Terrace from the junction with New Road for a distance northwards

of 150 feet.

On the eastern side of Palmerston Road for a distance southwards of 155 feet.

On the western side of Palmerston Road for a distance southwards of 30 feet.

# The Herefordshire County Council (Ross-on-Wye) (Traffic Regulation) Order, 1962

To prohibit the waiting of vehicles between the hours of 9.a.m. and 6 p.m. on weekdays (sub-ject to centain exceptions) in the following streets:

New Street: On the south side from its junction with Edde Cross Street to its junction with Broad

Street, and on the north side from its junction with Edde Cross Street eastwards for a distance of 10 yards and from its junction with Broad Street north-westwards for a distance of 50 yards.

Station Street : On the south side from its junc-tion with Broad Street to its junction with Henry Street.

Henry Street: East and west sides from its junc-tion with Station Street southwards for a distance of 20 yards.
